## **INFORMATION CONCERNING THE EXERCISE OF THE RIGHT OF WITHDRAWAL**

### **Right to retract**

You have the right to withdraw from this contract without giving any reason within a period of fourteen (14) days.

The withdrawal period ends fourteen (14) days after the day on your own, or a third party other than the carrier and indicated by you, physically take possession of the property.

To exercise the right of withdrawal, you must notify us at ALEXANDRE DE PARIS ZI -19, rue François Rochaix 01100 ARBENT your decision to withdraw from this contract by an unequivocal statement (e.g. regular mail, fax: fax number +33 (0) 4 74 73 55 21 - to the attention of Ms Marie Rosa or email at: [contact@alexandredeparis-store.com](mailto:contact@alexandredeparis-store.com)).

You can use the model return form which is mandatory.

In order the withdrawal period is valid, you only need to send your communication concerning the right of withdrawal before the expiration of the withdrawal period.

### **Effects of withdrawal**

If you withdraw from this contract, we will reimburse all payments received from you, including initial delivery costs, if existing at the time of ordering (**with the exception of the costs of return entirely to your charge and of additional costs arising from the fact that you have chosen, if necessary, an express delivery method other than the less expensive standard delivery method proposed by us**) without undue delay and in any event, not later than fourteen (14) days from the day we are informed of your decision to withdraw from this contract. We will refund using the payment method used at the time of the order, if necessary by your Paypal account or by your bank card or by transfer for international transactions (thank you to contact your bank details, including IBAN of your account), unless you specifically agree to a different way.

We may defer the refund until we have received the package.

**IMPORTANT: A full refund requires a complete return order. Unreturned products will be deducted from the balance and you will benefit from a credit note (=> a private code) on a future order of the amount of the returned products.**

You will need to return the goods to the following address ALEXANDRE DE PARIS ZI -19 rue François Rochaix 01100 ARBENT without undue delay and in any event, not later than fourteen (14) days after you have given us your decision to withdraw from this contract. This deadline is met if you send back the goods before the expiration of the fourteen (14) day period.
